

San Antonio Parrot Head Club Parrot Point System

The San Antonio Parrot Head Club (SAPHC) strives to follow the motto “Party with a Purpose”. Along those lines, members in good standing can earn Parrot Points by participating in the many activities that we hold throughout the year. Points will be accrued throughout a year, beginning after the latest Jimmy Buffett concert is announced and concluding the end of the month prior to the time that the new concert season begins (this year the period was March 1, 2007 until Feb 29, 2008). Couple memberships will have their total points averaged and placed on the priority list according to that point value. These Parrot Points may be used to determine eligibility in the event that the demand for PHiP club tickets exceeds the number of tickets that PHiP allocates for the club. The club members with the highest number of Parrot Points will be recognized quarterly.

There are plenty of events to attend/donate to in order to accrue Parrot Points, so plan accordingly throughout the year. The SAPHC Board of Directors (BOD) may add some events which will be publicized in advance. Events that are not club sanctioned will NOT get you Parrot Points unless the BOD qualifies an event and it is announced prior to the event. It is to your benefit to look through this list and plan what events you can attend or donate to. If you cannot attend events in person due to work/home constraints, there are events where donations can be made or you can have a friend drop them off for you. HOWEVER, it is each member’s responsibility to ensure they sign in for that event. If you do not sign in or get your name noted, then you will NOT receive credit for that event.
